give counsel, treatment and referral to overcome temporary infertility, thus helping childless couples attain their wanted children.

We have added two clinic sessions each week and increased our professional and volunteer staff. But the growing community needs and the problems of the returning servicemen and women require additional staff, space and supplies, and consequently increased financial support.
