

Dear President Roosevelt:

Enclosed are more petitions. In particular, the petitioners ask our President to convey to the British Government the immediate necessity for the abrogation of the Chamberlain White Paper. With half a million helpless human beings in Hungary faced with extermination the offer of the Churchill Government to extend 20,000 visas to Palestine is a tragic abuse of the Mandate, and betrayal of the Atlantic Charter.

Such evidences of a lack of good faith on Britain's part at a time like this can only lead to a corrosive cynicism. The raising of the red herring of an Arab-Jewish problem deceives no one. Too much publicity has already been thrown upon the part played by the British Colonial Government in the creation and the fostering of this myth. Men of the stature of Mr. Wilkie and Pierre Van Paassen have clearly indicated this in their writings, and I, for one, do not doubt their integrity. My thanks to Mr. Pehle for his recent kind acknowledgment.
