This is 57 for WRB in reply to Department's 31485 of July 27, 11 p.m.

Foreign Office advises that pursuant to Lengyel's request Swedish Legation Budapest was instructed to include names of Lengyels family with those concerning which Swedish Government had declared protective interest.

Foreign Office does not consider funds in question needed at this time.

Olsen suggests individual cables such as Lengyel's ^{to King} ~~balting~~ of Sweden should not be encouraged and funds should not be sent unless requested.
