Dear Mr. Pehle:

For use in the division of our forthcoming Year Book entitled "Directories of Agencies," we are revising the list which was included in the 1943 volume, and wish to include your agency. Enclosed is a form for your use in supplying the desired information.

This list will include not only agencies in the well-recognized fields of social work, but also governmental and voluntary agencies in a considerable number of related fields. This extension of the Year Book's scope is necessary because in many matters the distinctively social agencies must often work cooperatively with agencies in other fields or professions, and it is important to have a convenient, reliable record of national agencies in these other fields.

The volume will again include an index. In this your agency will appear, by name only, under each of its major activities in the field of social work or related to that field. These major activities should therefore be stated or clearly implied in the paragraph of your listing headed "Purpose and Activities." Please have this fact in mind in preparing that paragraph. If it is inadequate your agency may be incompletely indexed. If you have a department or committee on a subject related to social work that fact may appropriately be stated.

In order to have the material up-to-date we have postponed communicating with you as long as possible. I shall, therefore, appreciate a prompt return of the enclosed form. There is no charge for this reference to your agency's work, but we need your cooperation in order that the information may be correct.
