PAPERS OF AUBREY W. WILLIAMS

Aubrey Williams was executive director of the Wisconsin Conference of Social work from 1922 to 1932, and field representative of the American Public Welfare Association, 1932-33. In 1933 he joined the Roosevelt Administration as a field representative of the Federal Emergency Relief Administration, and became the assistant administrator of the FERA and the Civil Works Administration until 1935. He was executive director of the National Youth Administration from June 1935 until 1943, when he became director of the National Farmers Union. He was editor of SOUTHERN FARM AND HOME from 1945 until his death in 1965.

His papers consist of incoming and outgoing correspondence, memoranda, reports, drafts of speeches and writings, printed materials and newsclippings relating to his government career, but primarily to the National Youth Administration.
